

# General Terms and Conditions of Hire of any items

Please read the terms and conditions which form part of the contract once the deposit is made.

- **£50 deposit** will secure the date for you, with the balance due 10 days before the event
- Upon delivery a £100 cheque deposit will be required for potential damages and breakages, which will be refunded within 48 hours of collection if no damages
- Delivery within a 15 mile radius of NN10 is free of charge. Additional mileage will be charged at 50p per mile.
- Whilst we are happy for the items to be used outside, many of the items will get damaged if they get wet. We therefore ask that, should it be raining or snowing, the items are placed under cover. Under no circumstances should the items be left out overnight in the rain. The customer will be liable for replacement of any items with water damage.
- Please note, the Milk Churns will not show the damage for a few weeks, therefore if we are aware of them being left out in the rain, we will automatically charge £20 per churn for reconditioning fees.
- Venues must be made aware of your booking to ensure access is allowed
- Amendments to the booking can be made up to 14 days before delivery
- Should you need to cancel your booking;
  - A full refund of the deposit will be given up to 60 days before the delivery date
  - If cancellation is within 60 days, 50% of the deposit will be refunded.
  - If cancelled up to 14 days of the event, the deposit will not be refunded.

## Additional T&C for Cart and Accessory hire

- The Wooden Cart will be hired out for an agreed period of time. The cart and accessories remain the property of *Absolutely Vintage* and the customer takes full responsibility of the items, until collected by the company.
- In the event that the cart gets damaged beyond repair the full cost of £600 would be payable by the customer within 5 days
- Absolutely Vintage do not take responsibility for any food or beverages left over after the event, but will be happy to bag or decant them for you if collection is immediately after the event. You may need to ask the venue to store in the fridge for you.
- The Cheese Cart package provides sharp knives and the company do not take responsibility for usage of the knives, or any injuries obtained from use of knives.

The client hiring the props will be liable for any damage or loss.

Delivery and parking fees will be calculated at the time of booking.

If you cancel your event the deposit is non refundable, if less than 28 days before the date booked.

The balance will be due 28 days before the event

Cancellations that occur 28 days or less prior to the event full payment will be required.
